

TOR FOR THE REHABILITATION AND EXTENSION OF THE BUILDING OCCUPIED BY THE KENYA HIGH COMMISSION IN RWANDA-KIGALI.

I. Background

- * Engaged in the business for at least five (5) years.
- Certification issued by at least three (3) different clients attesting to the satisfactory services/completion rendered by the contractor.
- List of 3 qualified experts (with proofs) that will undertake the rehabilitation works.
- * Ready to take a public liability insurance before signing the contract of execution.
- Financial offer.
- ❖ The winner shall provide us performance guarantee of 10% of contract amount.
